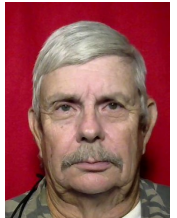

Vice President's Report

LEAD ABATEMENT

The week of March 15th, TCGC underwent a lead remediation that resulted in approximately 32,000 pounds of lead being removed from our backstops. The work was performed by professional lead remediation company, ReCoil Range Remediation at no cost to us. <https://recoilc.com>

While no Federal or State Regulations are in place to regulate shooting ranges, good stewardship of the facility dictates that the range periodically has the lead removed to minimize the environmental impact. Per the NRA Range Source Book. "Operational aspects of implementing the Environmental Stewardship Plan and properly documenting these activities should be included as part of routine range operations." "Remediation" means that most of the lead is removed.

**So be sure to wash for at least 20 seconds!!!!
For COVID and LEAD!!!**

Safety Report

Greetings Tri City Gun Club Members,

Brass Recycling: We have instituted a brass recycling program for members to allow them to sort through the recycled brass that comes from the black barrels on the ranges and the policy \ process is listed below:

1. At the end of each quarter, I empty the black brass recycle barrels on each range and put the brass in 5-gallon buckets, usually by range in the Stat House. I try not to comingle rifle and pistol range brass.
2. Members are allowed to sort through that brass and pick out what they want for personal use and the cost is \$1.00 per pound. You will need to provide your own container / baggies. It is a first come, first serve basis.
3. Payment instructions will be in the Stat House
4. When sorting through the brass, please remove steel and aluminum casings and throw them in the trash. Take dud rounds and dispose of them in the red ammo cans on the range. I will have a bucket for scrap brass, so please put scrap rounds i.e. 22LR, rim fire, dented cases, berdan primed cases, etc. in that bucket.
5. Do not open the boxes marked "Scrap" as that is what is in them and will ultimately be taken to a brass recycling center.
6. Clean up after yourself.

If you have any questions, please give me a call or send me a note.

Be safe and shoot straight, make sure your bullets impact the Backstop.

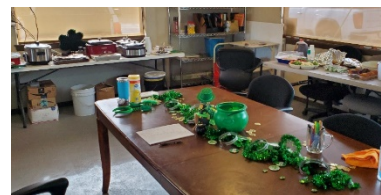
**The speed limit starting from the cattle guard thru the range is still 10 mph.

1. Meeting was called to order at 7:08 by Mark Erickson
2. Jamie and Bob are not at the meeting.
3. Lead abatement will be on the 15th and the 22nd.
4. Range Safety Officer- Ken Anderson - New gongs long range 200 yards. Handicap parking spaces will be added to the pavilion, will make easier access to shotgun.
5. Maintenance- Bill Hutcherson - Roofing expert still needed for short range. Workday March 20th. Lots of firewood available.
6. Vice President- Jamie - Raffle donations available online: Glock 10 mm \$10 each or 11 for 100. Friends of NRA Raffle \$20 each. We need volunteers for Friends of the NRA banquet!
7. Secretary- David Barbee - To become a reg member: Need to be an associate member for 3-years; Contribute to club and participate in monthly meetings as an associate; Apply to board-email secretary@tcgc.us
8. Treasurer- Woody Wooderson - We are working on a better description of the financing for sporting clays; this will come out of range improvement. Investment policy research on hold. Everyone seems to be a sporting clay finance expert!

9. Scheduler- Tara Nelson - This Sunday is our 1st 5 stand- Fundraising for the new sporting clays project. All the proceeds go back to the sporting clays. March 14th Luck of the Irish- Sporting clays and potluck lunch. April to November- Meetings will be held at the Pavillion. Sportsfest ad WOT have been cancelled for 2021. The sporting clays project is off to a good start (Tara has pics to prove it!!) Shotgun Checklist - Base for stands- Done; Purchase traps/ counters- Done; Prep road for power and conex delivery; Purchase 40' Conex for target storage/restroom.

 12. Mark Ericksen-President's Report - Range remediation (lead removal) will be scheduled for either March 15th or the 29th(weather permitting) by Recoil LLC ; Days of range closures will be announced as scheduled; Ranges affected: Long Range, Pistol, Short Rifle.
 13. The raffle happened.
 14. The meeting was called to close at 7:46 by Mark Ericksen
- General Meeting Minutes recorded and prepared by Amber Yelton.

Executive Meeting Minutes – March 18, 2021

1. Meeting called to order at 6:30 PM.
2. The minutes from the previous meeting were accepted.
3. Discussion was held over the OU shotgun team. They are seeking projects to work on.
4. Lead remediation has been completed. The equipment is still on the range, but is expected to be removed by Monday, the 22nd of March. Documentation of the remediation will be stored on our cloud drive.
5. Bill is considering retirement from the duties of the Maintenance Manager. He is still interested in continuing with mowing, spraying, and other light duty work. He is willing to train someone to take over the other duties that he currently covers for the club. The board is interested training someone to take over. There are questions regarding what the plan will be moving forward. We will need to determine if he would need to transition from a contractor to a statutory employee. We will also need to determine the duties of the Maintenance Manager vs. a maintenance contractor or a grounds maintenance specialist. The current position is in the capacity of special staff. Job descriptions will be identified using O*NET Online (<https://www.onetonline.org/>) and the NRA range sourcebook as a resource. Volunteer and working members' labor will also be considered. However, although regular tasks such as mowing may lean on that assistance, volunteer or other such temporary labor is not sufficiently consistent to provide the quality offered by a regular service or employee. We will review what services provided on the open market may cost as well. We will explore further and determine the path forward.
6. It was clarified that recycled brass is a club resource for the entirety of the membership. It is freely available to the members.
7. We need to update our insurance to reflect the new throwers, after the purchase is finalized. The throwers are currently being renewed with new wheels, fittings, etc.
8. The shotgun range will be closed temporarily for the removal of cable spans that were replaced with buried cable.
9. The OU Clay Target Team has added TCGC as an additional insured on their insurance policy.
10. We have a request for a life membership, and a request to be promoted to regular membership. A member is also awaiting renewal and will be provided assistance with the test. Several associate members are showing interest in becoming regular members.
11. A church group is interested in holding an event. Members may bring guests. However, sufficient RSO will be necessary. Ken will visit with the member.
12. We will be making some changes to our Wild Apricot data fields in order to reduce multiple points of entry for the same data and to routinize how the data is kept. We will now focus simply on our capacity to verify NRA numbers, rather than identifying if numbers are expired or not.
13. We will be canceling Office 365. Anything stored in OneDrive needs to be moved to Google Drive by 4/2/2021. We will be canceling Neat, effective 3/8/2022.
14. Go Daddy was billed in error. It will be refunded within the next few days.

15. There is some question regarding the vote for sporting clays. \$34K was allocated to cover the cost of the throwers and the counters that were available at a very reasonable price point. No other items were included. It was noted that TCGC owns all of the items that held and used by any of its shooting disciplines. The shooting discipline only **manages** the items. No disciplines own any assets. No shooting discipline is required to "pay back" the use of club funds allocated to the discipline. All discipline funds are TCGC funds held in TCGC's account. TCGC splits funds into separate disciplines, in order to allow each discipline to manage their own funds and to properly track any funds that they raise through donations by charging participants. This ensures that all funds are used according to the needs of discipline and that the club's share of any funds raised are remitted to the club. All of these funds are designated.
16. Sporting clays is moving along. Much of the dirt work is done. Plumbing and electricity are lined up and will be tied in at the archery range. The conex is in place. A trapper from Goldsby is assisting with the beavers.
17. Railroad ties will be placed after heavy equipment work is completed.
18. Range limiters complete with elevation control were demonstrated.
19. The meeting was adjourned at 8:07 PM.

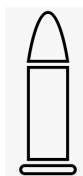
