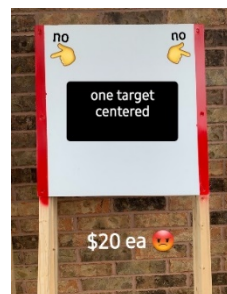
# Range Maintenance

Remember to turn off red lights when last to leave.



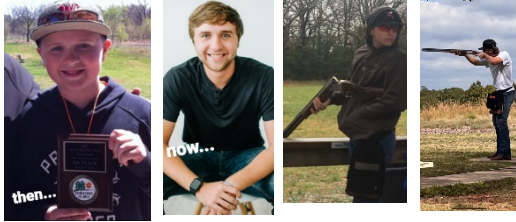
## NOTICE on Target Placement & Cost of Materials Pistol & Short Rifle Range

5. A woman who was accused of stealing copper from the club has been released from jail. Saturday is in person renewal at 9:00 AM.
6. The President reported that he doesn't know what happened to the beavers. The telephone poles will be moved to use for sporting clays.
7. Archery reported that the Youth Archery nights have been full and fun.
8. The Vice President noted that she is excited for black powder season! Life member badges that have taken the online quiz have been printed. Non-life members will be printed after renewals have closed.

10. The Member at Large reported the match on Saturday has been cancelled, but the range will still be closed so they can spray.
11. The Scheduler reported that the scheduling is scheduled.
12. The Treasurer reported that the budget has been submitted to the board and to the finance committee. The funds that aren't used for projects are swept into the General Fund.
13. Scott Steno has an RSO class coming up and he will have shotguns for sale.
14. There was a raffle.
15. The meeting was adjourned at 7:29PM by Mark Eriksen.

## Executive Meeting Minutes – October 21, 2021

1. The meeting was called to order at 6:00 p.m.
2. The previous meeting minutes were approved.
3. Friends of the NRA was briefly discussed.
4. Promotion to life membership was discussed.
5. Renewals and new member orientation were discussed. New member orientation could be held on the 8th of January. One could also be held in February.
6. The officer election deadline has been reached. Any additional nominations need to be submitted immediately.
7. 50% of the club's membership has been renewed. We have 90 regular openings.
8. Camp & Shoot went very well. It was reported as the best youth event people have participated in. A press release was prepared.
9. A member will be hosting a retirement party at the club.
10. It was determined that once a member has successfully completed their quiz, the quiz will not be retained.
11. An RSO class is being tentatively planned. The club has several members who can teach an RSO class. The club no longer has club funded trainers. We, as a club, need to recruit or train RSOs. The board is willing to help fund an RSO class.
12. There was some discussion regarding the frequent and regular attendance of guests at matches. A small fee goes to support this. However, members and non-members pay the same. It would not be unreasonable to charge non-members more to participate.
13. Club property inventory is being updated.
14. Tomahawks were discussed. The Boy Scouts of America has standards for tomahawks that the club will use for any tomahawks that it purchases.
15. A member did not renew last year, due to a processing error. He will pay his dues for last year and this year.
16. Range cold lighting was discussed. Red means **stop**, the range is cold.
17. Individual member issues were discussed. It was noted that members can look up their NRA card information on the website and the club will be happy to send individuals instructions on how to get their information.
18. It was noted that we all joined a gun club, not a computer. We still use computers.
19. Women on Target was discussed. Tara is ready to pass it on. Amber Yelton indicated interest in helping. Robin Cooper was offered as an option as well.
20. The accountant is working on forms for taxes.
21. The Goldsby Community Center is still going to be used for November thru February meetings. It was noted that the cost of the rental has tripled and that the rental is now for the full day. We do have a credit with Goldsby.
22. The finance committee has reviewed and approved the budget.
23. There was an issue with work hours being applied to user accounts. This has been resolved. This issue is primarily due to instructions not being followed.
24. The mailbox got overfilled. When the box was overfilled, the mail was placed into a tote. However, a second and third tote were misplaced by the post office. It appears that all our mail has been found. We do want to ensure that mail is being collected monthly. The post office did recommend that we get a larger box.

25. Maintenance activities are up to speed, but Randy wants a pony.  
26. The meeting was adjourned at 7:34 p.m.

Hello Tri-City members. My name is Hazen Bazinet and I am running to be your next Chief Range Safety Officer.

First an introduction for anyone I have not met - born and raised in rural east coast Canada, joined Army Reserve while in High School, am a Veteran of Royal Canadian Air Force, completed a Degree in Mechanical Engineering at Military College, served as an Aircraft Maintenance Officer. After early retirement for cutbacks, got into Electronics Manufacturing, first as a Support Engineer, as a manager, and as a Customer Engineer which led to relocation to Phoenix Arizona. Became a US citizen. A layoff resulted in a move to Oklahoma in 2016 to join Boeing as a Manufacturing Engineer. I met my wife Sue while serving, her favorite hobby is horses, so we bought a ranch near Washington. We've been busy maintaining and upgrading our little piece of Oklahoma. We have one son who was recently Deputized with Cleveland County, and a three-year-old Grandson who was born in Norman - a first gen Bazinet Oklahoman!

Canadian accent teaching Scouts to shoot. Served as Assistant Scoutmaster and on Troop's Leadership Committee. Certified as RO with National Range Officer Institute for USPSA. Was very active with Club in Arizona, last few years there was a Board Member as Coordinator for New Shooter Program. Joined Tri-City late 2016 and became a Regular Member after 3 years. Volunteered for annual Scout Camp & Shoot and starting this year also for Thursday Youth Program. Have maintained NRA certifications. Enjoy monthly matches at Tri-City and shoot USPSA at nearby clubs, volunteer as RO and help new shooters whenever needed. From all that I believe the primary quality I bring is a strong focus on safety while having fun! I've learned that in any type of RO role we must be firm and direct, but I've always done so with a calm and fair approach.

2) why do I wish to do it? First, I believe that if we don't continue to support safe shooting sports for all skill levels, eventually anti-gun influences will eliminate what we all enjoy. I've seen that happen in Canada in my lifetime and I fear we are within only a few generations of the same in America. So, I want to put my time and effort where my mouth is against that. Second, I think Tri-City is a great club, so I want to do my part for the Club's continued success. Third, last but not least, I want to do my part to ensure the safety of everyone who comes out to the Club.

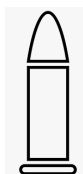
