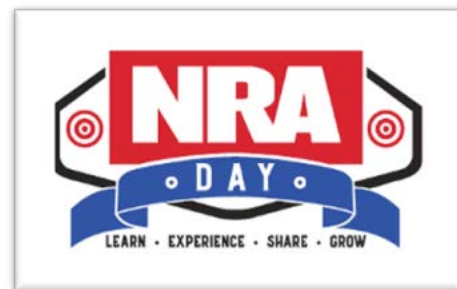

The February maintenance crew had a great day! We accomplished several tasks. We created another clean storage area, moved some panels to sporting clays that will work as barriers for the throwers, fertilized all ranges & more, road/parking maintenance, target boards, and perimeter

fence line inspection & sign replacement. In the next couple of weeks, we will be pre-emerging. Unfortunately, it was too windy Saturday to get it done. We plan to spray during evening hours but may have to shut down ranges if the opportunity arises on a calm day. The crew enjoyed Rudy's tacos for breakfast and had a great supervisor (Titan the wonder husky) to keep them motivated. A

big thanks to the guys for all their hard work.



A few reminders to help keep your range awesome:

- Extinguish all cigarette butts before putting in trash. Better yet, use your own ashtray/container. No smoking under covered areas or in buildings.
- NO cigarette butts in **Live Ammo** cans or brass buckets. Especially, while still burning.
- Brass buckets are not spittoons.
- Leave gas valves alone. Twice the gas has been turned off to the stat house during freezing temps.
- **No driving up/over any berms.** This is a gun club, not a 4-wheel drive club. Violators will be charged for repairs and maintenance to damaged berms. You have been recorded.
- Turn off range lights. Turn off bathroom lights and close doors.
- Speed Limit is 10mph or less....What's your hurry?
- Slugs and buckshot have no place on shotgun ranges.
- **1 target centered** on pistol & short rifle range.
- Currently, there is no pattern board for shotguns. Bring cardboard and place on a long-range berm. Take with you when finished.

Remember to cleanup and dump your shells and broken-down boxes in the blue dumpster. Lay the shooting stands down to prevent breakage and decock the throwers.

No slugs or buckshot is allowed. Steel barriers are not to be used for patterning.

## General Meeting Minutes – February 3, 2023

1. The meeting was called to order at 7:04 p.m.
2. The previous meeting minutes were approved.
3. Stuart H was appointed as the TCGC representative of the ORA. Last August the local ORA elected new officers. The Sharpshooter will be coming out soon. They need updated email and contact info for all members. They would like for us to host the shotgun championships. The future's looking bright! There will be more updated information in the next Hangfire. The membership expressed interest in the ORA president speaking at the next meeting. To give them your updated contact information, there is a link on the TCGC website or visit [oklahomarifle.org](http://oklahomarifle.org).
4. A member brought his Granddaughter, Elisa Boozer, who is an active youth member at the club, and is in the Junior Olympics. She goes to the Olympic camps in the summer, and shoots in their competitions. In September, Elisa went to Puerto Rico for an international shoot. 2 weeks ago, she shot in a 3 position competition. Recently in Sapulpa, she defended her title as the champion, and walked away with the gold. She is an amazing shot! She was invited to participate in the club military bolt match. Elisa is thinking about joining the ROTC. She has been on TV and published in the newspaper many times. She prefers Precision Air because it's cleaner. She brought her Pardini rifle to show the club. There are weights for adjustments. The gun is a 177 caliber.
5. Greg Sutterfield has been asked to advocate for OK2A. The McClain County coordinator has asked Greg to assume his role and he excitedly accepted. He would like members of the club to participate in the McClain County chapter of OK2A.
6. Archery announced that we will not be having Youth Archery next week.
7. Sportsfest is on the 1st of April. This is an event for kids. There will be 84 participants and is hosted by our club. We are looking for muzzleloader instructors, air rifle support, and 22 rifle support. We also need more RSOs for this event. There is a link on the club website to sign up and help. It is \$25 per child. We do have room for more participants.
8. The shotgun pricing committee has been quite an adventure. The committee's purpose is to principally come up with pricing for shotgun clays. The Board voted and accepted the recommendations of the committee. There were 39 people who expressed interest in participating in the pricing committee. Ken Anderson was elected the chair and Tara Nelson was elected as the secretary. They looked at the shotgun fund and a pricing structure for clay targets. The shotgun discipline fund is a fund only for

shotgun. You can see this reflected in the treasurer report. These funds are raised by fundraisers. The first thing they looked at is how to cover the price of clays for the next 15 months. We need to cover the cost of breakage and maintenance on the throwers, and maintenance on the range itself. They developed the pricing criteria after looking over all the info. target. The discipline consists of the members of that shooting group. When the shotgun discipline group is created, there will be more transparency. A question was asked about if they took into consideration the pricing of different targets. The answer was yes. This is still a work in progress. Sportsfest and Women on Target are included in the numbers of clays stated. A member wanted to make clear that the shotgun pricing committee is invested in the future of shotgun. In the budget for 2023 \$50,000 was allocated for sporting clays.

9. The Treasurer reported that, just to clarify, the purpose of the shotgun pricing committee is shotgun pricing. The committee is complete, they have come up with a recommendation for pricing. Looking forward, this committee is no longer a thing. There was a framework developed that will help us as we move forward. He pointed out that nobody cared about this until money was involved. He can appreciate that change is hard, but it's how the club grows. We have multiple disciplines at the club. Disciplines come and go, they change names, and interests. They usually have special equipment. Some are open to the club, and some are not. So far, there has been a different set of rules for each discipline. We are coming up with a standardized document that states the rules of each discipline. We need a consistent way with how we handle the disciplines as a board. Shotgun is confusing when it comes to this. There are actually multiple disciplines within shotgun. Disciplines also have the authority to form a committee. They are a steering committee who makes recommendations to the board. If the discipline elects not to have a committee, the board will serve as the committee for that discipline. The rules in the bylaws state that there is a 1-year life span for a discipline committee. His goal is, by the end of this month to have the standardization complete by the end of this month. Each discipline will have a different account for funds.
10. The Chief Range Safety Officer reported that he wants to echo the call for RSOs. Sportsfest is one of his favorite events of the year. We are catering to a member's request to shoot clay targets with a longbow. We defined some rules for this, they are posted. It looks like it could be fun. He is also making a new document for each range's rules to simplify things.
11. The Vice President reported if you have any extra 12-gauge shells you would like to donate to the youth group, see me! Springfield Hellcat pro is being raffled off now. Tickets are \$10 ea \$50 will get you 6, \$100 gets you 12. There is a gentleman interested in doing a black powder training class. There will be more info next meeting.
12. The Secretary reported that according to our bylaws, every February, the president is supposed to call for members of a nominating committee. It is an important committee that keeps the leadership of the club fresh. The president called for volunteers. Mike Whittaker, Will Thompson, Charles Kliever, and Goldie Welch was nominated. All four were voted in as the 2023 nominating committee.
13. The Scheduler asked if the RSOs are interested in RSO t-shirts, lanyards, or a hat. If you are interested, shoot me an email.
14. Kevan Riley thanks the club for letting the club put on the scout events. Topshot is coming up in a couple of weeks if you are interested in helping out. It's a lot of fun! This is at the Diamond H Scout Ranch.
15. Maintenance reported that they are looking for volunteers to help work on the sporting clay range. Give your name to Randy or Tara.
16. The meeting was adjourned at 8:28 p.m.

# Officer Meeting Minutes – February 16, 2023

1. The meeting was called to order at 6:30 pm.
2. The previous meeting minutes were approved.
3. There was discussion regarding the conduct of meetings. Members were unhappy with a sense of disorder at a recent meeting. The board and members need the opportunity to hear and consider information, before making decisions.
4. Sportsfest was discussed. We have all the targets that we need but may need other consumable items. We are still seeking RSOs.
5. The club would benefit, in general, from purchasing timelines that indicate when a particular needs to be purchased and available for use.
6. Volunteer opportunities for Norman FFA were discussed. The students would have supervision. The club will not provide supervision. Liability coverage would also be a concern. We are not certain that we will have opportunities that would be appropriate.
7. Recording club and board meetings was raised as a concern by a member. Club membership meetings, board meetings, or other official meetings may be recorded by members. Nobody is particularly excited about recording, but it cannot be reasonably prevented. Civility was discussed.
8. The shotgun committee, pricing, and planning were discussed. There was additional discussion over disagreements over communications. Concerns were raised about rounds not being counted accurately or entirely. It was requested that on the first of each month maintenance record the thrower logs, to be reported to the board. There was some concern that funds initially allocated for sporting clays may have been based on inaccurate data, and thus may be insufficient. We need to determine where we are financially, prior to determining the next step.
9. The nomination committee has had its first meeting. They are considering flyers to solicit nominations. The board agreed that this was a good idea. The nominating committee asks that members who are overseeing disciplines refer members to them. A flier will also be circulated. The board gave its compliments.
10. A guest requested a 400-yard range.
11. A bylaw change proposal was made and presented to the board. The proposal was signed by six members. The intent of the change is to ease processing of adding or renewing members. The proposal was discussed by the board. A concern was raised, because membership to the NRA is not included as a requirement in the change. The NRA membership requirement was not included because the review and verification of NRA membership is extraordinarily time consuming and cannot be vetted. Because the NRA memberships cannot be vetted, there is no reasonable way to enforce the current requirement to be a member of the NRA. Dropping the requirement is in no way a renunciation or criticism of the NRA. It is only a recognition of the operational reality of attempting to enforce a bylaw requirement that we simply do not have the means or capacity to enforce.
12. Smoking and cigarette butt cans on the range were discussed. Butts are being found in a lot of places where butts do not belong. There is no desire to ban smoking, but there is also no desire to install more butt cans.
13. We are receiving ammo from grants, but still need more shotgun ammo. We will purchase more shotgun ammo in bulk. We did not get archery equipment and may need to renew some equipment later in the year.
14. Managing trees in the sporting clays area was discussed. Canopies will be raised to around 6-feet, to allow for visibility, but trees will be left in place wherever possible.
15. The discipline document will be completed and shared soon.
16. A financial report was given.
17. Electronic waivers have been developed and tested. There is still some programming required to integrate the waivers into events, etc. A tablet, in an armored box, will be placed on an outside wall of the Stathouse, for use by those who do not have devices to complete waivers. A programmer has been contracted to provide programming services.
18. The meeting was adjourned at 7:54 p.m.

# Bylaw Amendment Proposed at 2/16/2023 Board Meeting:

**Bylaw Amendment** that changes membership start and end dates to be the date that the member joined the club (instead of every membership being January and ending in December) and makes renewals due one year after joining the club (instead of October of every year).

This eliminates confusion caused by renewals being due in October even though memberships don't end until December. This also makes renewals and opening up for new members easier to manage which will contribute to the mission of our club to grow the shooting sports.

## **Section 3.01 will be changed to read as follows:**

Section 3.01. ELIGIBILITY. Any citizen or legal resident of the United States twenty-one (21) years of age or older and legally able to handle firearms may become a member of this organization after meeting all of the following conditions: a) passing the administrative and safety rules quiz as determined by the board, b) completing a Range & Safety Orientation, c) paying the current initiation fees and dues established by the board, and d) subscribing to the following pledge, to-wit: [pledge remains unchanged]

## **Section 3.012 will be changed to read as follows:**

Section 3.012. TERMS OF MEMBERSHIP. Memberships shall be valid for one (1) year (a) beginning on the effective date of membership (join date) noted in the member's membership record or (b) beginning on the anniversary of the join date. Membership requires the individual member (a) complete and submit an application for membership or renewal, as designated by the board, (b) demonstrate understanding of TCGC administrative and safety rules, and c) pay any dues and fees required within one (1) month of their join date or for subsequent years of membership, within one (1) month the anniversary of the member's join date. Failure to complete the membership requirements will result in the termination of membership. Former members, other than life members, must apply as a "New Member."

## **Section 3.013 will be deleted; its contents have been incorporated into 3.012**

### **Current Bylaws:**

**Section 3.01. ELIGIBILITY.** Any citizen or legal resident of the United States twenty-one (21) years of age or older and legally able to handle firearms may become a member of this organization after meeting all of the following conditions: a) being a member of the National Rifle Association ("NRA"); b) attending an Annual Range & Safety Orientation; c) paying the established initiation fees and dues; and d) subscribing to the following pledge, to-wit:

**Section 3.012. TERMS OF MEMBERSHIP.** The membership year shall be from January first to December thirty-first. Members must go through an annual process which includes: Range & Safety Orientation, updating personal data, NRA Membership verification, payment of dues, and verification of work hours each year by October 31st.

**Section 3.013. RENEWAL.** ALL Members must renew their membership by October 31st of each year. Failure to do so will result in the loss of membership. Any member who loses his or her membership must apply as a "New Member".

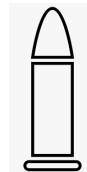
